- 1. Salary for the post of Director will be commensurate to qualification and experience of the candidates.
- 2. The Assistant Professor shall be eligible for consolidated monthly salary of Rs. 50,000/- (Rs. Fifty Thousand) per month only.
- 3. The candidate will not be entitled to any other benefits, which are admissible to the regular employees of the Central University of Rajasthan.
- 4. The relaxation in qualification etc. shall be applicable to the SC/ST/OBC/Physically challenged candidates as per the University/ GOI rules.
- 5. This engagement will not vest any right to claim for regular appointment in the University or for continued services in the University.
- 6. The University reserves the right to terminate this engagement any time even before the stipulated period in case of unsatisfactory performance, misconduct or any other administrative reasons/ compulsions.
- 7. In case of any dispute/ ambiguity that may occur in the process of selection, the decision of the University shall be final.
