The Chairman welcomed all members of the Committee and emphasized on having the meeting with all members preferably in person so as to improve the quality of interaction. He apprised the Committee about the progress achieved by the University from 27 <sup>th</sup> June, 2024 to 07 <sup>th</sup> November, 2024.
	Hon'ble Vice Chancellor informed the committee on growth in the intake of the students in the Academic Year 2024-25. He also informed about the rigorous efforts made in filling up of vacancy and recruitments made during last 2 years & 10 months in respect of Teaching and Non-Teaching Staff. He also apprised the Committee Members about the promotion of Research Facilities under Central Instrumentation Laboratory costing Rs.41.77 Cr. by adding various equipments procured during period.
41-1.0	Signing of 04 MoUs with Tula State University, Russia; Gifu University, Japan; Indian Council of World Affairs (ICWA) & MSTC Limited, Kolkata (a Mini Ratna Category-1 CPSE under GoI) was also apprised to the Committee. The Vice-Chancellor also expressed heartfelt thanks to the Ministry of Education and University Grants Commission for according sanction of new proposals viz. Transit Mess and Dining Hall (400 Capacity) for B6 Boys Hostel, Kendriya Vidyalaya Building, Indoor Sports Facility & Hostel of 600 Capacity, which undoubtedly will be an addition towards further growth of the University and catering to the earnest need of the students as above.
	Central University of Rajasthan has also been fortunate enough to secure Gold Medal in the 5 <sup>th</sup> International Yogasana Sports Cup, 2024 by Ms. Darshana Hazarika, PhD. Scholar. Now, the work will be executed through PSUs, being engaged as Project Management Consultants for the purpose.
	University is thankful to Ministry of Social Justice and Empowerment for approval of the projects.

#### The matter was placed before the Building and Works Committee for consideration.

#### **Discussions in BWC:**

The Committee noted that since establishment of the Central University of Rajasthan (CURAJ) in the year 2009, the Central Public Works Department (CPWD) has been engaged as an executing agency for all the building projects and other construction works of the University.

However, it has been experienced for a long time that requisite co-operation is not being extended by CPWD authorities that are resulting in significant delay at every stage including planning, tendering, execution and monitoring of the projects. Due to this delay in completion of Construction Projects, University has suffered a lot in managing routine functioning of the University (not only monitory aspects (cost escalations) but also academic affairs).

#### Details of concerns with CPWD are as follows:

- a) Lack of proper and regular monitoring has been observed due to which the projects have been/getting abnormally delayed. For example, Scheduled date of Completion of 4A2 building was 09.02.2023. Presently, progress as on September 30, 2024 is 85%.
- b) Reservation in sharing of adequate information by CPWD like reports of quality tests conducted at site, details of the arbitration cases, justification and other details of huge deviation etc.
- c) It is observed that in most of the cases, tendered amount of projects was about 60% of the AA&ES cost. It has been observed in many projects that CPWD has completed the work consuming the entire AA&ES with no scope of utilizing the savings, even exceeded the AA&ES without approval of the University. Details are provided below:

- d) As per standard clause of MoU/ CPWD Manual, 33% amount needs to be deposited to CPWD, though now it is 10% after Ministry of Education Orders. This deposit amount needs to be maintained with CPWD till project end. Depositing 10% amount with CPWD has significant cost for Government of India / University, especially in the case of HEFA Loan, where Government of India bears the cost of interest on HEFA loan.
- e) For example, if we consider the construction projects of worth Rs. 250 Crore, as per MoU with, 10% amount is to be deposited with CPWD during the project duration, leading to Rs. 1.38 Crore per annum interest (@5.5% rate applicable on HEFA loan), to be paid by Govt. of India through MoE and CURaj.
- f) As per terms and conditions of tender under consideration, payment to the contractors as per the running bills, will be made directly by the HEFA. Thus Government can save this interest amount.

Hence, considering all the above points, proposal to engage one of the Public Sector Undertaking/ Govt. Organisations to act as Project Management Consultant for the University was initiated as per GFR Rule 133.

#### Salient features of proposed MOU are as under:

(iii)

The Project Monitoring Agency for the above works / projects shall carry out the entire planning and monitoring from concept to commissioning to ensure good quality of work as per norms of Government /PSU manuals. The stipulated time schedule is as below:

- (i) Time for pre-construction activities : 3 months
- (ii) Time for construction activities : 18 months
  - Defects liability period after Handing Over : 18 months

It will be the responsibility of PMC to prepare the detailed tender documents comprising the technical specifications, bill of quantities, approved designs, drawings, general terms/conditions, special conditions if any, specifying the stages (such as plinth, R.C.C. frame work, brickwork, plates etc.) of the projects for the RA bills/payment purpose and submit to the CURAJ for the approval.

After finalization of conceptual drawings with detailed specification, EPC tender may be floated if the PMC deems it fit. However the responsibility of Architectural services shall be of PMC in any case. The vetting of structural drawings from any IIT/NITs and approval of detailed Architectural and service drawings by Central University of Rajasthan over and above the approval of PMC shall be mandatory.

The tender will be scrutinized and vetted by the CURAJ and it will be free for any modifications and alterations in conditions of NIT /tender documents if required. PMC will assist CURAJ in tendering process, however, work will be awarded to the Contractor by the University.

PMC shall ensure that contractor completes the work within the tendered cost. Before incurring the excess expenditure over and above, prior approval of the CURAJ is to be taken for the same. Extra/ substituted items/ deviations in agreement quantities/ Extension of time/ bills of payments and all other work related matters shall be settled by PMC in consultation with CURAJ as per relevant provisions of the contract between PMC / CURAJ and the contractor(s). For the works, over and above the tendered value, the CURAJ will not make the payment, in case of no prior approval from CURAJ. PMC's prime objective would be to ensure completion of project without time and cost over runs.

Payment will be released by the University through HEFA directly to the Contractor not the PMC based on the certification of the bills by PMC and CURAJ engineers for the pre-decided stages (as per tender document) of completion of work.

Issues of Completion Certificate, Handing over of Buildings and services to Central University of Rajasthan up to satisfaction of end users/Central University of Rajasthan are included in the Scope of work of the PMC.

Provision of Liquidated Damages: In case, completion of the project is delayed due to reasons attributable to the contractors/agencies/suppliers engaged for the project, liquidated damages @ 1 % (one percent) of the awarded contract value for each week of delay subject to a maximum of 15% (fifteen percent) of the awarded contract value will be imposed on the contractor executing the project.

In case, completion of work is delayed due to the reasons attributable to the PMC (or to the agency engaged by the PMC), liquidated damages @ **1% (one percent)** on consultancy fee for each week of delay subject to a maximum of **15% (fifteen percent)** of the total Consultancy fee will be imposed on the PMC.

If the project is not completed as per schedule of the period of contract due to any reason, the services of PMC shall be deemed extended till completion of the projects on same terms & conditions, without prejudice to any other rights of the CURAJ and without any additional amount or change in the consultancy charges.

Extensive deliberations have been made by the University Authorities on these provisions and the same have been decided based on the experience with CPWD and keeping in view the number of benefits to the University. These provisions will help in saving of funds in terms of completion of the project within the tendered cost, no liability of interest on advance, timely completion of project without any cost overrun and overall control of the project in the hands of client i.e. CURAJ.

## During the discussions, SE cum PD, MNIT Circle, CPWD Jaipur requested to recuse himself from this agenda item.

**BWC Resolution:** BWC took a note of the tender floated for appointment of PMC, its evaluation report and Financial evaluation of all the bidders. While taking into consideration, all the points mentioned above, the Committee appreciated the efforts of the University and approved the proposal to appoint M/s UPRNN, Noida as Project Management Consultant at 2.8% (+GST) of project cost being L1 bidder, and further recommended to place it before the Finance Committee and Executive Council.

Total financial implication would be Rs. 4.78 Cr. {Rs. 144.76 x 3.30 (2.8% + GST) and the same will met through HEFA.

<u>Resolution</u>: The matter was deliberated at length by the Committee Members and all the aspects of the matter were taken into consideration. The Committee noted that the proposal is as per GFR 133 and as per GOI guidelines on the matter. It was also discussed that clause of incentive for early completion of work may also be considered in the tender document as per Rules.

The proposal was recommended by the Finance Committee to Executive Council for approval Keeping in view performance of CPWD and benefits from the proposal.

During the discussions, SE cum PD, MNIT Circle, CPWD Jaipur requested to recuse himself from this agenda.

BWC noted that the University has floated the tender on 25.10.2024. while considering past experiences as discussed in agenda item 25-4.1, the Committee supporting the stand of the University, approved the proposal to appoint a Project Management Consultant for the above eight projects as well. It was also recommended to place it before the Finance Committee and Executive Council.

Estimated financial implication on the rates available would be approx. Rs. 3.36 Cr. (Rs.101.73 Cr x 3.30% fee) and the same will met through original funding source of the project i.e. HEFA/otherwise.

<u>Resolution</u>: The Committee was informed that MOU with HEFA has been signed on 05.11.2024. Finance Officer was authorized by the Vice-Chancellor for the same due to occupancy of Registrar in charge.

	For safety and security of girls students and resolving the above issues, estimate amounting to Rs. 1,17,88,400/- for providing & fixing of steel wire fabric mesh with M.S. Frame in the balconies, has been received from the CPWD vide its letter No. 141 dated 03.04.2024.
	The matter was considered by the Building and Works Committee.
	Discussion: The Committee noted and appreciated the concern of the University for the safety of girl students and stressed upon the said work should be considered for boys' hostel also in the next phase.
	BWC resolved to approve the proposal with an estimated cost Rs. 82,51,880/- (30% below based on past experience) and recommended to place it before the Finance Committee and Executive Council.
	<u>Resolution:</u> It was noted that no separate funding will be needed for the above work as it will be carried out from Internal Revenue Generation (IRG). 	The BWC was apprised that presently University has only one seminar hall of 250 capacities and another of 80 capacity in 4A-5 and 4A-6 building respectively. As University is having currently 35 departments and need of teaching facility with audio visual set-up for integrated courses as well, it was planned to equip existing available seminar hall with air ducting and false ceiling to convert these halls into seminar halls and classroom facility so that it will be utilized as a teaching learning facility for integrated and professional courses, where we are presently lacking the classroom infrastructure.

	1. No electrical provision has taken in this estimate as per discussion with the CUR authority.
