Sub: - NTA Declares the Result/NTA Scores of Common University Entrance Test (UG) – 2024 – Reg.

The National Testing Agency has been mandated by the **Ministry of Education and UGC** to conduct the Common University Entrance Test (CUET) for admission into **Undergraduate Programmes in Central Universities under the Ministry of Education, and other participating Universities / Institutions / Organizations / Autonomous Colleges** for the **Academic session 2024-2025**.

The CUET (UG) provided a **single window opportunity to students seeking admission in any of the Central Universities (CUs) or other participating organizations (including State Universities, Deemed and Private Universities) across the Country** especially those from rural and other remote areas, help establish better connections with the Universities. A single Examination enabled the Candidates to cover a wide outreach and be part of the admissions process to various Central Universities and other participating Universities.

The National Testing Agency conducted the Common University Entrance Test (UG) – 2024 [CUET (UG) – 2024] in Hybrid Mode for about **14,99,790** (Fourteen Lacs, ninety-nine thousand, seven hundred and ninety) **unique registered candidates**. These candidates applied for **various combinations of subjects across 283 Central, State, and other participating universities / Institutions / Organizations** for the **Academic session 2024-2025** at various Examination Centres located in different cities across India and abroad, as per the following schedule.

The CUET (UG) – 2024 was conducted for admission in the academic session 2024-25 in Hybrid mode as per the following details:

The CUET (UG) – 2024 provided access and flexibility in the following ways:

- In total, 63 subjects (33 languages, 29 Domain-Specific Subjects, and One General Test) were offered for the candidates in the CUET (UG) – 2024. Two new subjects **Fashion Studies and Tourism** were added for the first time. A Candidates could choose a maximum of 06 Subjects including languages (Indian and Foreign) and General Test.
- For Subjects such as Accountancy, Economics, Physics, Computer Science / Informatics Practices, Chemistry, Mathematics / Applied Mathematics, and General Test, the duration of the test was **60 minutes**.
- The candidates had applied for **various** unique combinations of subjects across **283** Universities.
- The total number of Question Papers was **99** and the number of Questions was **59110**. These were used over **09 days in Shifts**.
- The medium of the Question Paper was in **13 languages (English, Hindi along with regional languages i.e. Assamese, Bengali, Gujarati, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu)** so that the candidate from different regions could attempt in their own medium.
- An overall choice in all subjects was given to all candidates in order to cater to the decision of different Boards across the country regarding the reduction of the syllabus. In all subjects, candidates had to attempt any 40 questions out of 50 except for the General Test where 50 questions were to be attempted out of 60.
- In addition to **379** cities in India, the CUET (UG) - 2024 examination was also conducted in **26 cities** outside the country in **Abu Dhabi, Bangkok, Brasilia, Cape Town, Canberra, Colombo, Doha, Dubai, Frankfurt (Germany), Hanoi, Hong Kong, Jakarta, Kathmandu, Kuala Lumpur, Kuwait City, Lagos, Manama, Moscow, Muscat, Oslo, Ottawa, Port Louis, Riyadh, Sharjah, Singapore, and Washington D.C.**
- Grievances of individual students based on their experience in CUET (UG) – 2024 were considered.

- For the preparation of Question papers, **about 1195 subject Experts and 565 translators** were involved in the massive exercise of preparing the Question Papers for CUET (UG) – 2024.

Candidates were given an opportunity for the challenge from **07 July to 09 July 2024** along with the Provisional Answer Key, Question Paper, and Recorded responses. In this duration, **about 9512** Answer Key challenges were received out of which **1782** were unique challenges. Candidates were also given representation through e-mails and letters. Those were also shown to the concerned Subject Experts. Based on their feedback and after incorporating the changes, the Final Answer Keys were prepared which were used in preparing the Result of CUET (UG) – 2024.

The Role of NTA is confined to the Registration of candidates, conduct of the test, hosting of answer keys, inviting challenges, finalizing answer keys, preparing and declaring results, and hosting Score Card. A merit list will be prepared by participating Universities/organizations. Universities will decide about their individual counselling on the basis of the Scorecard of CUET (UG) - 2024 provided by NTA.

The Examination was monitored in the following ways:-

- A Central Control Room was opened to monitor and facilitate the smooth conduct of the Examination on the ground. **397** City Coordinators, **3240** Observers, **28** Deputy Observers, and **35 Virtual Observers** were deployed.
- Live CCTV Surveillance was planned in all examination centres to curb malpractices in the examination. The NTA also made arrangements for live viewing of remote locations of all examination centres from the Control Room located in the NTA premises of New Delhi. Recording of CCTV Systems was also done.
- The examination centres were also monitored using AI-based Video Analytics and Virtual Observers.
- In order to stop cheating using mobile networks, Jammers were installed in all the Centres.

Candidates were given an opportunity to see their responses to the Question Papers and to challenge the Answer Keys. Challenges received online were placed before the concerned Subject Experts for verification. The result was prepared based on the Final Answer Keys and the same is being declared today i.e. **28 July 2024** on <https://exams.nta.ac.in/CUET-UG/>

The result of candidates is in the process of being shared with the Universities. Candidates are advised to be in touch with the respective universities and Institutions for further details.
