Master's Degree in Biochemistry, Life Sciences, Sports Science, Nutrition Food Science/ Technology, Home Science, or Physiology or Engineering from an Indian University, or an equivalent degree from an accredited foreign University.2. At least 55% in Master degree and at least 60% in at least two preceding examinations.3. Demonstrable record of interest in Sports Science, preferably Sports Nutrition, Sports Biochemistry, Sports Physiology.4. National Eligibility Test (NET) in Life Science, Home Science, Physical Education or ARS-NET in Food Technology.5. Candidates, who have been awarded a Ph.D. Degree in accordance with the provisions contained in the Para 4.1(I)(A)(ii), UGC Regulations, 2018 are exempted from the requirement of the minimum eligibility condition of NET.

Terms & Conditions:

1. The Assistant Professor shall be eligible for consolidated monthly amount based on minimum pay in the Pay Level-10, [Vertical Range of Pay Level Rs. 57700-182400] with applicable allowances and the same has been fixed on consolidated monthly salary of Rs.67500/-.
2. The candidate will not be entitled to any other benefits, which are admissible to the regular employees of the Central University of Rajasthan.
3. This engagement will not vest any right to claim for regular appointment in the University or for continued services in the University.
4. The University reserves the right to terminate this engagement any time even before the stipulated period in case of unsatisfactory performance, misconduct or any other administrative reasons/ compulsions.
5. In case of any dispute / ambiguity that may occur in the process of selection, the decision of the University shall be final.
6. The candidate will have to perform such other duties and work as assigned by the Central University of Rajasthan from time to time.
7. On expiry of the period of this engagement as per the offer of engagement, the candidate will not be required to turn up for duties unless the further extension is provided by the university.
8. If it is detected by the Central University of Rajasthan during the period of engagement that academic credentials / age / experience are without standing, fake or substandard or your documents are false, fabricated, manufactured, tampered with or the candidate is not eligible for the post as per the prescribed educational qualifications and experience etc. which could not be detected at the time of selection due to whatever circumstances, the engagement shall be terminated forthwith and action will be initiated against the candidate as per rules.
9. In case of any dispute/suit or legal proceeding arises against the University, the Jurisdiction shall be restricted to the Rajasthan High Court Bench Jaipur.
